## ASSIGNMENT OF TRADEMARKS

Assignor hereby grants the law firm of Arnstein & Lehr LLP, 120 South Riverside Plaza, Suite 1200, Chicago, Illinois 60606 authority and power to insert on this instrument any further information that may be necessary or desirable for identifying the Trademarks, Registrations or applications for purposes of recordation in the United States Patent and Trademark Office or in any foreign country, including the addition to Exhibit A of any Trademarks, Registrations or pending applications that may later be discovered to be owned by Assignor on the effective date of this Assignment.

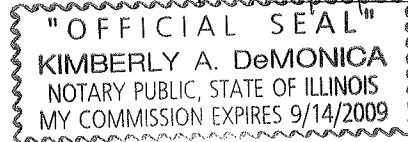

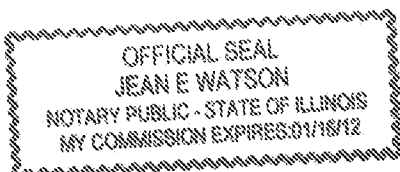
