Release of Lien on Trademarks

This Release of Lien on Trademarks (the "Release"), dated as of July 30, 2004 is made by Wachovia Bank, N.A., ("Bank"), as agent for the financial institutions party to the Fifth Amended and Restated Credit Agreement, dated as of December 23, 2002, among the Bank, Wachovia Securities, Inc., Toronto Dominion (Texas), Inc. and General Electric Capital Corporation, and the other companies listed on the signature pages thereto, in favor of Hollinger International Inc., Digital Chicago Inc., Chicago Sun-Times, Inc., Midwest Suburban Publishing, Inc., Pioneer Newspapers Inc., Chicago Sun-Times Features, Inc. and Toronto Dominion (Texas), Inc. (collectively, the "Grantors").

WHEREAS, Grantors entered into an Intellectual Property Security Agreement, dated as of December 23, 2002 and recorded in the United States Patent and Trademark Office as of January 22, 2003 at Reel 2656, Frame 0930, pursuant to which Grantors granted to the Bank a security interest in and lien on all right, title and interest of the Grantors in certain trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks") to secure the performance of certain obligations (the "Obligations");

WHEREAS, the Obligations have now been satisfied, Grantors has requested that the Bank release any and all interest it may have in the Released Trademarks, and the Bank has agreed to do so.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Bank does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.
