**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS RELEASE (INTELLECTUAL PROPERTY) is given as of August 11, 2009, to Intechra LLC, a Mississippi limited liability company (the "Company") by The Bank of New York Mellon, a New York banking corporation, as administrative agent (the "Agent") under that certain Credit Agreement dated as of July 11, 2007 (said Credit Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the "Credit Agreement") by and among the Company and Intechra Logistics LLC, a Mississippi limited liability company ("Logistics" and together with the Company, the "Borrowers" and each, individually, a "Borrower"), the Agent and the financial institutions named therein (collectively, together with their respective successors and assigns party to the Credit Agreement from time to time, the "Lenders").

WHEREAS, the Company entered into (i) a Trademark Security Agreement, dated as of July 11, 2007, which was recorded in the United States Patent and Trademark Office on July 26, 2007 at Reel 3590, Frame 0574, and (ii) a Trademark Security Agreement, dated as of August 6, 2009 (collectively, the "Security Agreements"), which was recorded in the United States Patent and Trademark Office on August 6, 2009 at Reel 04039, Frame 0583, pursuant to each of which the Company granted to the Agent, for the benefit of the Lenders, a security interest and mortgage to all of the Company's right, title and interest in and to the Trademark Collateral recited therein (as defined in the Security Agreements) including but not limited to the property in Exhibit A thereto, and identified in Exhibit A to this Release; and,

WHEREAS, in connection with the execution and delivery of that certain Asset Purchase Agreement by and among the Lenders, Intechra Holding Corporation and Intechra Group, LLC, and the Agent, for the benefit of the Lenders, desires to release its security interests in and liens upon the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent, for the benefit of the Lenders, hereby releases its lien on and security interest in all of the Company's right, title and interest in and to the Trademark Collateral and reassigns any and all interest it may have in such Trademark Collateral to the Company.
