INTELLECTUAL PROPERTY ASSIGNMENT

THIS IS AN INTELLECTUAL PROPERTY ASSIGNMENT signed on the 20th date of JULY, 2009, and having an effective date of the 31st of JULY, 2009 between Indalex Holdings Finance, Inc., a Delaware corporation, Indalex Holding Corp., a Delaware corporation, Indalex Inc., a Delaware corporation, Caradon Lebanon, Inc., a Tennessee corporation, and Dolton Aluminum Company, Inc., a Wisconsin corporation (collectively, the "Assignors"); and Sapa Extruder, Inc., a Delaware corporation ("Assignee");

WHEREAS, Assignors are the owner of certain patents and patent applications including those set forth in the attached Schedule A, certain trademarks including those set forth in attached Schedule B, certain trade names including those set forth in attached Schedule C; and certain copyrights including those embodied in the software applications set forth in attached Schedule D (collectively, the "Intellectual Property");

WHEREAS, pursuant to a certain Asset Purchase Agreement dated as of June 16, 2009 (the "Asset Purchase Agreement"), by and among the Assignors and SAPA Holding AB ("AB") Assignors have agreed to sell to AB, and AB has agreed to purchase said Intellectual Property, including the goodwill associated with any of the trademarks therein, the right of priority associated with any of the patent and patent applications therein and any resulting patents, divisional applications, continuation applications, reissued patents, reexamination certificates, or other patents associated therewith, the right to make derivative works associated with any of the copyrights therein, and the right to sue based on any of the rights included therein to the extent provided for in the Asset Purchase Agreement; and

WHEREAS, pursuant to that certain Assignment and Assumption Agreement dated July 21, 2009, by and among AB and Assignee, and in accordance with Section 12.3(a) of the Asset Purchase Agreement, AB assigned to Assignee all of its right, title, interest and obligations as US Purchaser under the Asset Purchase Agreement with respect to the Intellectual Property.

NOW, THEREFORE, for the consideration previously provided and hereby acknowledged, the parties hereto, intending to be legally bound:

1. **Assignment and Transfer of Intellectual Property.** Assignors hereby transfer to Assignee all right, title and interest in and to the Intellectual Property and the goodwill associated with any of the trademarks therein to the extent provided for in the Asset Purchase Agreement.

2. **Governing Law.** THIS ASSIGNMENT SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH (A) THE INTERNAL LAWS OF THE STATE OF DELAWARE WITHOUT GIVING EFFECT TO RULES GOVERNING THE CONFLICT OF LAWS AND, (B) TO THE EXTENT APPLICABLE, THE BANKRUPTCY CODE.

3. **Counterparts.** This Assignment may be executed in any number of counterparts and by the undersigned in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same instrument. 


