## INTELLECTUAL PROPERTY SECURITY INTEREST ASSIGNMENT AGREEMENT

**THIS INTELLECTUAL PROPERTY SECURITY INTEREST ASSIGNMENT AGREEMENT** (the "Agreement") is made and entered into as of the 17<sup>th</sup> day of July, 2009, by BANK OF AMERICA, N.A., as Second Lien Collateral Agent, having an office at 1455 Market Street, CA5-701-05-19, San Francisco, CA 94404, Attention: Joan Mok ("Assignor"), in favor of THE BANK OF NEW YORK MELLON, a banking corporation formed under the laws of the State of New York, having an office at 600 East Las Colinas Blvd., Suite 1300, Irving, TX 75039 Attention: Melinda Valentine/Vice President ("Assignee").

### W I T N E S S E T H

WHEREAS, Assignor is a party to the Security Instrument (as hereinafter defined) on that certain intellectual property described on Exhibit A annexed hereto and made a part hereof or otherwise subject to the Security Instrument; and

WHEREAS, the parties hereto desire that Assignor assign to Assignee all of Assignor's right, title and interest in and to the Security Instrument.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and agreed, and for the mutual and dependent covenants herein contained, Assignor and Assignee hereby covenant and agree as follows:

1. Assignment. Assignor does hereby transfer, assign, grant and convey to Assignee all of its right, title and interest in and to that certain Second Lien Trademark Security Agreement (recorded at the United States Patent and Trademark Office on May 15, 2007 at Reel 3541 and Frame 0778), together with any rider, addendum, exhibit, schedule and attachment thereto (the "Security Instrument"), together with all attendant liens, rights, title, assignments, interests (including security interests), and filings pertaining to or arising from the Security Instrument. Furthermore, Assignor does hereby grant and delegate to Assignee any and all of the duties and obligations of Assignor under the Security Instrument from and after the date hereof.

2. Representations and Warranties of Assignor. This Assignment is an absolute assignment. This Assignment is made without recourse, representation or warranty, express or implied.

3. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the state in which the Assignee is located.

4. Successors and Assigns. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.

5. Partial Invalidity. Each provision of this Assignment shall be valid and enforceable to the fullest extent permitted by law. If any provision of this Assignment or the application of such provision to any person or circumstances shall, to any extent, be invalid or

unenforceable, then the remainder of this Assignment, or the application of such provision to persons or circumstances other than those as to which it is held invalid or unenforceable, shall not be affected by such invalidity or unenforceability.


