ASSIGNMENT AND ASSUMPTION

Reference is made to the Guarantee and Collateral Agreement, dated as of October 14, 2004 (as amended, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”), among B&G Foods, Inc. and certain of its subsidiaries, collectively, as “Grantors” under and as defined therein, and Lehman Commercial Paper Inc. (hereafter, the “Existing Agent”), as the “Administrative Agent”. Reference is also made to (i) the Intellectual Property Security Agreement made by B&G Foods, Inc. and recorded in the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0532, (ii) the Intellectual Property Security Agreement made by Burnham & Morrill Company (f/k/a Heritage Acquisition Corp.) and recorded in (A) the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0646 and (B) the U.S. Copyright Office on October 25, 2004 at V3516 D480, (iii) the Intellectual Property Security Agreement made by Burnham & Morrill Company, as successor-in-interest to Ortega Holdings, Inc and recorded in the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0561, (iv) the Intellectual Property Security Agreement made by Burnham & Morrill Company, as successor-in-interest to Maple Grove Farms of Vermont, Inc. and recorded in the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0634, (v) the Intellectual Property Security Agreement made by Bloch & Guggenheimer, as successor-in-interest to Trappey’s Fine Foods, Inc. and recorded in the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0626, (vi) the Intellectual Property Security Agreement made by Bloch & Guggenheimer, Inc. and recorded in (A) the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0568 and (B) the U.S. Copyright Office on October 25, 2004 at V3516 D482, (vii) the Intellectual Property Security Agreement made by Polaner, Inc. and recorded in (A) the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0539, and (B) the U.S. Copyright Office on October 25, 2004 at V3516 D481, and (viii) the Intellectual Property Security Agreement made by William Underwood Company and recorded in the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0581, each dated as of October 15, 2004 in favor of the Existing Agent, and (ix) the Intellectual Property Security Agreement made by Bloch & Guggenheimer, Inc. and recorded in the U.S. Patent and Trademark Office on January 11, 2006 at Reel/Frame No. 3225/0363, dated as of January 10, 2009 in favor of the Existing Agent (collectively, the “Intellectual Property Security Agreements”). Unless otherwise defined herein, terms defined in the Guarantee and Collateral Agreement and used herein shall have the meanings given to them in the Guarantee and Collateral Agreement.

Credit Suisse has succeeded to all of the Existing Agent’s rights and obligations as the “Administrative Agent”, and the parties are executing this Assignment and Assumption to further evidence such succession with respect to the Trademarks, Patents, Copyrights and Trademark Licenses owned by each Grantor and identified in each of the Intellectual Property Security Agreements.

Accordingly, effective as of August 5, 2009, the Existing Agent hereby irrevocably assigns, without recourse, to Credit Suisse , as successor “Administrative Agent” (in

such role, the “Successor Agent”), and Successor Agent hereby assumes, all of Existing Agent’s rights and obligations as the “Administrative Agent” in, to and under the Intellectual Property Security Agreements, including, but not limited to, the security interest granted in the Trademarks, Patents, Copyrights and Trademark Licenses set forth on Exhibit A hereto.

From and after the Effective Date, (a) the Successor Agent shall be a party to each of the Intellectual Property Security Agreements and have the rights and obligations of the Administrative Agent thereunder and shall be bound by the provisions thereof, and (b) the Existing Agent shall relinquish its rights and be released from its obligations under the Intellectual Property Security Agreements.

This Assignment and Assumption shall be governed by and construed in accordance with the laws of the State of New York.
