**TRADEMARK ASSIGNMENT**



NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign to Assignee all right, title and interest in and to said Trademark, the registration thereof, and the common law rights thereto, together with the good will of the business symbolized by said Trademark, and in and to any and all causes of action, either in law or in equity, and the right to enforce any rights and to file any causes of action, including the right to recover damages, for any past, present or future infringement or misappropriation of said Trademark, effective *nunc pro tunc* as of December 31, 2004.
