TRADEMARK SECURITY RELEASE AGREEMENT

This TRADEMARK SECURITY RELEASE AGREEMENT (this "*Trademark Security Release*") is made as of August 21, 2009, by U.S. Bank National Association, located at 1 Federal St., Boston, MA 02110, not in its individual capacity, but solely as Trustee and Collateral Agent (as defined in the Indenture) under that certain Indenture, dated May 26, 2004, between U.S. Bank National Association and Milacron Inc., as amended and supplemented (the "*Indenture*") (the "*Agent*").

WHEREAS, pursuant to those certain Trademark Security Agreements and other related financing documents (the "*Trademark Security Agreements*"), D-M-E Company, Inc., a Delaware corporation, located at 2911 Stephenson Highway, Madison heights, MI 48071, D-M-E U.S.A. Inc., a Michigan corporation, located at 2911 Stephenson Highway, Madison heights, MI 48071, Milacron Inc., a Delaware corporation, located at 4165 Half Acre Rd., Batavia, OH 45103, Milacron Industrial Products Inc., a Michigan corporation, located at 1160 White Street, Sturgis, MI 49091, Nickerson Machinery Chicago Inc., an Illinois corporation, located at 10 Keith Way, Hingham, MA 02043, Oak International, Inc., a Michigan corporation, located at 1160 White St., Sturgis, MI 49091, Uniloy Milacron Inc., a Delaware corporation, located at 5550 Occidental highway, Tecumseh, MI 49286, and Uniloy Milacron U.S.A. Inc., a Michigan corporation, located at 10495 Highway M52, Manchester, MI 48158 (each referred to individually as a "*Company*" and, collectively, as the "*Companies*") have granted to Agent a security interest in certain trademarks owned by the Companies, including but not limited to the trademarks set forth in Schedule IA (all such trademarks collectively referred to herein as the "*Trademarks*"); and

WHEREAS, the obligations underlying the security interest are no longer owed and Agent no longer has any interest in the Trademarks; and

WHEREAS, the Trademark Security Agreements were recorded at the United States Patent and Trademark Office at various reels and frames and on various dates, including, but not limited to, Reel 2998, Frame 0312, at Reel 2998, Frame 0337, at Reel 2998, Frame 0319, at Reel 2998, Frame 0305, at Reel 2998, Frame 0344, at Reel 2998, Frame 0351, at Reel 2998, Frame 0298, and at Reel 3099, Frame 0328, on June 25, 2004; and

WHEREAS, the Companies have requested that Agent execute this Trademark Security Release for the purpose of recording the release of its lien on the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby releases any and all claims, liens, and other encumbrances in and to the Trademarks and reassigns any and all rights, titles and interests therein, without any representation, recourse or undertaking by Agent, to the applicable Company.
