**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of August 13, 2009, from JPMORGAN CHASE BANK, N.A., as Collateral Agent (the "Agent") for certain banks and other financial institutions (the "Secured Parties"), to Affinia Group Inc., Brake Parts Inc. and Wix Filtration Corp. LLC (collectively, the "Grantors").

WITNESSETH:

WHEREAS, pursuant to the Guarantee and Collateral Agreement, dated as of November 30, 2004, made by the Grantors and each other Subsidiary Loan Party identified therein in favor of the Agent (the "Collateral Agreement"), a security interest (the "Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, an agreement evidencing the Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office on January 14, 2005, at Reel 3104 and Frame 0352; Reel 3104 and Frame 0363 and Reel 3104 and Frame 0333; and on January 22, 2009 at Reel 3927 and Frame 0961.

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest, granted pursuant to the Collateral Agreement, in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Collateral Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:


1. Definitions. The term "Trademark Collateral" as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided by reference in the Collateral Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest, granted pursuant to the Collateral Agreement, in the Trademark Collateral, and any right, title or interest of the Agent, granted pursuant to the Collateral Agreement, in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest, granted pursuant to the Collateral Agreement, contemplated hereby.
