TERMINATION AND RELEASE OF SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF SECURITY AGREEMENT (this "Termination"), is dated as of October 1, 2009, and made by PNC BANK, NATIONAL ASSOCIATION, as Agent, having an office at 4720 Piedmont Row Drive, Suite 300, Charlotte, North Carolina 28210 ("Grantee") to STREAM INTERNATIONAL INC., a Delaware corporation ("Grantor"), with its chief executive office at 20 William Street, Suite 310, Wellesley, Massachusetts 02481.

WHEREAS, pursuant to that certain Security Agreement dated as of April 13, 2004 (the "Original Security Agreement") a security interest was granted by Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined), which security interest was ratified and confirmed pursuant to that certain Fifth Amended and Restated Revolving Credit, Term Loan and Security Agreement dated as of January 8, 2009 (the "Amended and Restated Security Agreement", and together with the Original Security Agreement, the "Security Agreements");

WHEREAS, the Original Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on April 21, 2004, at Reel 2952 and Frame 0727 and on August 5, 2008, at Reel 3829 and Frame 0047; and

WHEREAS, Grantee now desires to terminate and release the Security Agreements and all related documents;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.
2. Release of Security Interest. Grantee hereby terminates the Security Agreements and all related documents and terminates, releases and discharges its security interest in the Trademarks.
