reel/frame 003728/0001 and corrected by reel/frame 003731/0892 recorded on March 4, 2008, copies of which are attached as Exhibit A.

The provisions of Section 13 of the Security Agreement (as defined in the Trademark Security Agreement), to the extent applicable, are hereby incorporated by reference, mutatis mutandis.
