# TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of October 26, 2009, from General Electric Capital Corporation, in its capacity as administrative agent and collateral agent (in such capacity, together with its successors and permitted assigns, the "Administrative Agent") for itself, the Lenders, and each other Secured Party (as defined in the Term Loan Credit Agreement, dated as of March 3, 2008 (as the same may be amended, restated supplemented or otherwise modified from time to time, the "Credit Agreement")) to Dayton Superior Corporation ("Grantor").

#### WITNESSETH:

WHEREAS, pursuant to the Guaranty and Security Agreement dated as of March 3, 2008 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified) in favor of the Administrative Agent (the "Security Agreement") and the Trademark Security Agreement dated as of March 3, 2008, in favor of the Administrative Agent (the "Trademark Security Agreement"), Grantor mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, and granted to the Administrative Agent for the benefit of the Secured Parties, a Lien on and security interest (the "Security Interest") in, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office, at Reel 3731, Frame 0583 on March 4, 2008, and at Reel 3947, Frame 0440 on March 6, 2009; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby states as follows:

- 1. <u>Definitions</u>. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement and the Trademark Security Agreement.
- 2. <u>Release of Security Interest</u>. The Administrative Agent hereby terminates, cancels, releases, and discharges its Security Interest in the Trademark Collateral including without limitation, the Trademark Collateral listed in Exhibit 1 attached hereto. Any and all right, title, or interest of the Administrative Agent in, to and under such Trademark Collateral and all proceeds thereof, including without limitation, the goodwill of the business connected with the use of, and symbolized by, the Trademark Collateral and any and all causes of action which may exist by reason of infringement of the Trademark Collateral, shall hereby cease and become void.
- 3. <u>Further Assurances</u>. The Administrative Agent hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest in the Trademark Collateral contemplated hereby.
