## **ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS**

ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS, dated as of October 29, 2009 (this "Agreement"), by and among CIT Lending Services Corporation ("CIT"), as administrative and collateral agent under the Credit Agreement (as defined below), DelStar Technologies, Inc. ("DelStar"), U.S. Netting, Inc. ("U.S. Netting" and together with DelStar, the "Grantors"), and RBS Citizens, N.A. ("Citizens").

CIT, as administrative and collateral agent under that certain Amended and Restated Credit Agreement dated as of March 17, 2006 (as amended, restated, supplemented or otherwise modified from time to time in accordance with its terms, the "Credit Agreement"; capitalized terms used herein and not otherwise defined herein shall have the meanings specified in the Credit Agreement) by and among DelStar, Inc., DelStar Holding Corp., DelStar, the lenders party thereto (the "Lenders") and CIT, as Agent, has a security interest in and has taken a collateral assignment of the trademarks listed on Schedule 1 attached hereto (the "Trademarks") for the benefit of the Lenders.

The Grantors granted to CIT, as Agent under the Credit Agreement and the other Transaction Documents, a security interest in and collateral assignment of the Trademarks pursuant to the terms of the Pledge and Security Agreement and pursuant to the terms of a Trademark Security Agreement dated as of March 17, 2006 (the "Trademark Security Agreement") made by the Grantors in favor of CIT, as Agent under the Credit Agreement and the other Transaction Documents, which was recorded with the United States Patent and Trademark Office on March 23, 2006 on Reel 003275, Frame 0036.

Effective as of the date hereof, CIT has assigned all of its rights and obligations as Agent under the Credit Agreement and the other Transaction Documents to Citizens. Accordingly, the security interests in and collateral assignment of the Trademarks granted in favor of CIT, as Agent under the Credit Agreement and the other Transaction Documents has been assigned to Citizens, as the successor Agent under the Credit Agreement and the other Transaction Documents (in such capacity, the "Successor Agent").

Each Grantor hereby acknowledges and confirms that the security interest in and collateral assignment of the Trademarks granted to CIT, as the Agent pursuant to the terms of the Pledge and Security Agreement and the Trademark Security Agreement has been assigned to the Successor Agent and that such security interest, as assigned, is in full force and effect. Each Grantor hereby acknowledges and affirms the rights and remedies of the Successor Agent, as Agent with respect to the security interest in the Trademarks made and granted in the Pledge and Security Agreement and the Trademark Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.


