## ASSIGNMENT OF TRADEMARK

2. **Warranty of Title**. Assignor hereby warrants to Assignee that the Trademarks and all other items transferred herein are free and clear of all liens, claims and encumbrances of any kind and Assignor, for itself and its assigns, shall warrant and forever defend Assignee's title to the Trademarks and other transferred assets from and against any and all persons or entities whatsoever.

3. **Binding Effect; Benefits**. This Assignment shall be binding upon the Assignor and its successors and assigns, and shall inure to the benefit of Assignee, its nominees, successor and assigns.

4. **Governing Law**. This Assignment shall be governed by and construed in accordance with the laws of the [Commonwealth of Pennsylvania].
