INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, this "*IP Security Release*") dated November 6, 2009, is made by DEUTSCHE BANK TRUST COMPANY AMERICAS, as administrative agent (the "*Administrative Agent*") for the Secured Parties, in favor of the persons listed on Exhibit A (collectively, the "*Grantors*"). All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the IP Security Agreement (as defined below).

WHEREAS, Grubb & Ellis Company, a Delaware corporation, entered into a Third Amended and Restated Credit Agreement dated as of May 18, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*"), with the Administrative Agent and the Lender Parties party thereto.

WHEREAS, as a condition precedent to the making of Advances and the issuance of Letters of Credit by the Lender Parties under the Credit Agreement and the entry into Secured Hedge Agreements by the Hedge Banks from time to time, each Grantor executed and delivered that certain Third Amended and Restated Security Agreement dated as of May 18, 2009 made by the Grantors to the Administrative Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Security Agreement*").

WHEREAS, under the terms of the Security Agreement, the Grantors granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantors, and executed that certain Third Amended and Restated Intellectual Property Security Agreement dated as of May 18, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*IP Security Agreement*") for recording with the United States Patent and Trademark Office, the United States Copyright Office and other governmental authorities.

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office at reel 3991 frame 0807 and at reel 22723 frame 506 on May 21, 2009.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

SECTION 1. Release of Security Interest. The Administrative Agent does hereby release and convey to the Grantors, without recourse, representation or warranty of any kind, all of the Administrative Agent's right, title and interest in and to the Grantor's right, title and interest in and to the Collateral granted pursuant to the IP Security Agreement, including the Collateral listed on Schedules A, B and C.

SECTION 2. Governing Law. This IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.

IN WITNESS WHEREOF, the Administrative Agent has caused this IP Security Release to be duly executed and delivered by its officer thereunto duly authorized as of the date first above written.
