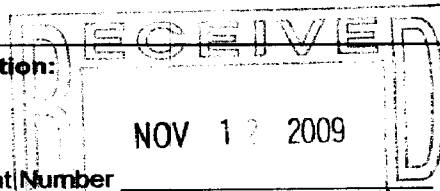

TRADEMARK SECURITY AGREEMENT**

NUNC PRO TUNC

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**, is made by the Bank of New York Mellon, a New York banking corporation with offices at One Wall Street, New York, NY 10286, formerly known as The Bank of New York with offices at 101 Barclay Street, 21st Floor, New York, New York 10280 ("BNY").

WHEREAS, pursuant to the terms of a certain Security and Pledge Agreement dated as of June 1, 1993 (the "Security Agreement") between Uniroyal Technology Company, et al. ("the Company") and BNY, the Company granted to BNY a security interest in and lien on the Company's SILAPRENE trademark, Serial No. 73063287, Registration No. 1051839 (the "Trademark"); and

WHEREAS the Security Agreement was recorded with the U.S. Patent and Trademark Office on June 7, 1993 at Trademark Reel 0986 and Frame 0029; and

WHEREAS, title in and to the Trademark was assigned by the Company, and was subsequently reassigned to subsequent owners such that the Trademark is now registered in the name of a new record title holder, purported to be Royal Adhesives and Sealants, LLC, a Delaware limited liability company (the "Record Owner"); and

WHEREAS, BNY has agreed to terminate and release its security interest in, lien on, and all of its right, title and interest in the Trademark as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BNY hereby terminates and releases, NUNC PRO TUNC, its security interest in, and first priority lien on, the Trademark effective as of November 9, 2001.
