**NOW, THEREFORE**, Assignor, for and in exchange for the consideration set forth in the Purchase Agreement, the receipt of which is hereby acknowledged, does hereby transfer and assign to Assignee, and Assignee hereby accepts the transfer and assignment of, all of Assignor's right, title and interest in, to and under the Marks, together with the goodwill associated therewith or which is symbolized thereby, all rights to all causes of action to sue for infringement of any Mark, whether arising prior to or subsequent to the date of this Assignment of Trademarks, including the right to all revenues arising or obtained from any such action, and any and all renewals thereof that may hereafter be secured under the laws now or hereafter in effect in the United States and in any other jurisdiction, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment of Trademarks not been made.
