## ASSIGNMENT AND ASSUMPTION AGREEMENT

Reference is made to (i) the Second Amended and Restated Credit Agreement, dated as of November 17, 2009 (the "Restated Credit Agreement"), by and among PROTECTION ONE, INC. ("Holdings"), PROTECTION ONE ALARM MONITORING, INC. (the "Borrower"), the several banks and other financial institutions or entities from time to time parties thereto as lenders, J.P. MORGAN SECURITIES INC., as sole lead arranger and sole book manager, and JPMORGAN CHASE BANK, N.A., as administrative agent (in such capacity, together with its successors and assigns in such capacity, the "Administrative Agent"), and the other agents and arrangers parties thereto, (ii) the Guarantee and Collateral Agreement, dated as of April 18, 2005 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Guarantee and Collateral Agreement"), by and among Holdings, the Borrower, each of the other Grantors party thereto and Bear Stearns Corporate Lending, Inc. (the "Existing Agent"), (iii) the Trademark Security Agreement, dated as of April 18, 2005 (the "Borrower Trademark Security Agreement"), between the Borrower and the Existing Agent, (iv) the Trademark Security Agreement, dated as of April 18, 2005 (the "NMSC Trademark Security Agreement"), between Network Multi-Family Security Corporation ("NMSC") and the Existing Agent, (v) the Copyright Security Agreement, dated as of April 18, 2005 (the "Borrower Copyright Security Agreement"), between the Borrower and the Existing Agent, (vi) the After-Acquired Trademark Security Agreement (First Supplemental Filing), dated as of April 24, 2006 (the "Borrower First Supplemental Trademark Security Agreement"), between the Borrower and the Existing Agent, (vii) the After Acquired Trademark Security Agreement (First Supplemental Filing), dated as of April 24, 2006 (the "NMSC First Supplemental Trademark Security Agreement"), between NMSC and the Existing Agent, (viii) the Trademark Security Agreement, dated as of April 2, 2007 (the "IASG Trademark Security Agreement"), among American Home Security, Inc., Criticom International Corporation, National Alarm Computer Center, Inc., Integrated Alarm Services, Inc., Everest Video Systems, LLC, Monital Signal Corporation and Integrated Alarm Services Group, Inc. (collectively, the "IASG Entities") and the Existing Agent, (ix) the Patent Security Agreement, dated as of April 2, 2007 (the "IASG Patent Security Agreement"), among the IASG Entities and the Existing Agent, and (x) the Copyright Security Agreement, dated as of April 2, 2007 (the "IASG Copyright Security Agreement" and, together with the Borrower Trademark Security Agreement, the NMSC Trademark Security Agreement, the Borrower Copyright Security Agreement, the Borrower First Supplemental Trademark Security Agreement, the NMSC First Supplemental Trademark Security Agreement, the IASG Trademark Security Agreement, the IASG Patent Security Agreement and the IASG Copyright Security Agreement, the "Intellectual Property Security Agreements"), among the IASG Entities and the Existing Agent.

Capitalized terms not otherwise defined herein have the respective meanings ascribed to them in the Guarantee and Collateral Agreement or the applicable Intellectual Property Security Agreement, as the context may require.

WHEREAS, pursuant to the Borrower Trademark Security Agreement, and the security interest which was recorded with the U.S. Patent and Trademark Office on June 6, 2005 at Reel/Frame No. 3097/0436, the Borrower granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the Trademarks listed on Schedule I, and all Goodwill associated with such Trademarks and all Proceeds of any and all of the foregoing;

WHEREAS, pursuant to the NMSC Trademark Security Agreement which was recorded with the U.S. Patent and Trademark Office on June 6, 2005 at Reel/Frame No. 3097/0447, Network Multi-Family Security Corporation granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the Trademarks listed on Schedule II, and all Goodwill associated with such Trademarks and all Proceeds of any and all of the foregoing;

WHEREAS, pursuant to the Borrower Copyright Security Agreement which was filed with the Library of Congress, Copyright Office prior to the date hereof, the Borrower granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the Copyrights listed on Schedule III, and all Goodwill associated with such Copyrights and all Proceeds of any and all of the foregoing;

WHEREAS, pursuant to the Borrower First Supplemental Trademark Security Agreement which was recorded with the U.S. Patent and Trademark Office on April 24, 2006 at Reel/Frame No. 3295/0395, the Borrower granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the Trademarks listed on Schedule IV, and all Goodwill associated with such Trademarks and all Proceeds of any and all of the foregoing;

WHEREAS, pursuant to the NMSC First Supplemental Trademark Security Agreement which was recorded with the U.S. Patent and Trademark Office on April 24, 2006 at Reel/Frame No. 3295/0404, Network Multi-Family Security Corporation granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the Trademarks listed on Schedule V, and all Goodwill associated with such Trademarks and all Proceeds of any and all of the foregoing;

WHEREAS, pursuant to the IASG Trademark Security Agreement which was recorded with the U.S. Patent and Trademark Office on July 18, 2007 at Reel/Frame No. 3583/0242, Criticom International Corporation granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the Trademarks listed on Schedule VI, and all Goodwill associated with such Trademarks and all Proceeds of any and all of the foregoing;

WHEREAS, pursuant to the IASG Trademark Security Agreement which was recorded with the U.S. Patent and Trademark Office on July 18, 2007 at Reel/Frame No. 3583/0252, Integrated Alarm Services Group, Inc. granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the Trademarks listed on Schedule VII, and all Goodwill associated with such Trademarks and all Proceeds of any and all of the foregoing;

WHEREAS, pursuant to the IASG Trademark Security Agreement which was recorded with the U.S. Patent and Trademark Office on July 18, 2007 at Reel/Frame No. 3583/0262, Monital Signal Corporation granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the Trademarks listed on Schedule VIII, and all Goodwill associated with such Trademarks and all Proceeds of any and all of the foregoing;

WHEREAS, pursuant to the IASG Patent Security Agreement which was recorded with the U.S. Patent and Trademark Office on July 18, 2007 at Reel/Frame No. 019572/0326 granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the Patents listed on Schedule IX, and all Goodwill associated with such Patents and all Proceeds of any and all of the foregoing;

WHEREAS, pursuant to the IASG Copyright Security Agreement which was recorded with the Library of Congress, Copyright Office on July 20, 2007 at Microfilm V3554D752P1-7, the grantors party thereto granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the Copyrights listed on Schedule X, and all Goodwill associated with such Copyrights and all Proceeds of any and all of the foregoing;

WHEREAS, (i) Existing Agent has resigned in its capacity as administrative agent in accordance with the terms of Section 10.9 of the Original Credit Agreement (as defined in the Restated

Credit Agreement) and (ii) pursuant to that certain Amendment and Restatement and Resignation and Appointment Agreement, dated as of November 17, 2009, the Lenders comprising Required Lenders (as such terms are defined in the Original Credit Agreement) have appointed JPMorgan Chase Bank, N.A. as successor administrative agent (in such capacity, the "Successor Agent").

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, each of the Existing Agent and the Successor Agent hereby agree as follows:

The Existing Agent hereby irrevocably assigns to the Successor Agent without recourse, and the Successor Agent hereby assumes from the Existing Agent, the interest in and to the Existing Agent's rights and obligations under the Intellectual Property Security Agreements (the "Assigned Interest"), as of the Effective Date (as defined below).

The effective date of this Assignment and Assumption Agreement shall be the date of execution by all parties (the "Effective Date"). Following the execution of this Assignment and Assumption Agreement, it will be delivered to the Successor Agent for recording by the Successor Agent pursuant to the Guarantee and Collateral Agreement and the Intellectual Property Security Agreements with the United States Patent and Trademark Office and the Library of Congress, Copyright Office.


From and after the Effective Date, (a) the Successor Agent shall be a party to the Guarantee and Collateral Agreement and the Intellectual Property Security Agreements and shall have the rights and obligations of Administrative Agent thereunder and under the other Loan Documents and shall be bound by the provisions thereof, and (b) the Existing Agent shall relinquish its rights and be released from its obligations under the Guaranty and Collateral Agreement and the Intellectual Property Security Agreements.

This Assignment and Assumption Agreement shall be governed by and construed in accordance with the laws of the State of New York.
