TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of November 17, 2009, by WEBSTER BANK, NATIONAL ASSOCIATION, formerly known as Webster Bank ("Webster").

WITNESSETH:

WHEREAS, THE YOFARM COMPANY, a Delaware corporation, ("Grantor") and Webster were parties to a Trademark Security Agreement dated as of November 18, 2002 (the "Assignment"), pursuant to which Grantor granted a security interest to Webster in certain trademarks (the "Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Webster, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on November 21, 2002, at Reel 2620, Frame 0187; and

WHEREAS, Grantor has requested that Webster release its security interest in the Trademarks and Trademark Rights and reassign the same to the Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Webster hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Rights"):

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all products and proceeds of the foregoing, including without limitation, any claims by Grantors against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Webster hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Webster, all of Webster's right, title and interest in and to the Trademarks and the Trademark Rights.
