INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**IP Security Agreement**") dated as of October 27, 2009, is made by the Persons listed on the signature pages hereof (collectively, the "**Grantors**") in favor of WILMINGTON TRUST FSB, as collateral agent (the "**Collateral Agent**") for the benefit of the Secured Parties (as defined in the Security Agreement referred to below).

WHEREAS, HEADWATERS INCORPORATED, a Delaware corporation (the "**Company**"), has entered into an Indenture, dated as of October 27, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Indenture**"), with WILMINGTON TRUST FSB, in its capacity as Trustee and as Collateral Agent, and the Guarantors party thereto.

WHEREAS, each Grantor has executed and delivered that certain Pledge and Security Agreement dated as of October 27, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Security Agreement**") by and among the Company, the subsidiaries of the Company party thereto (including the Grantors) and the Collateral Agent. Terms defined in the Security Agreement and not otherwise defined herein are used herein as defined in the Security Agreement.

WHEREAS, under the terms of the Security Agreement, the Grantors have granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in and lien on, among other property, certain intellectual property of the Grantors, and have agreed as a condition thereof to execute this IP Security Agreement for recording by the Company with the U.S. Patent and Trademark Office, the United States Copyright Office and other governmental authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

**SECTION 1. Grant of Security.** Each Grantor hereby grants to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in all of such Grantor's right, title and interest in and to the patents, trademarks (provided that no security interest shall be granted in any United States intent-to-use Trademark applications to the extent and for so long as the creation by a Grantor of a security interest therein would result in the invalidity, unenforceability or loss by such Grantor of any rights therein), copyrights and exclusive copyright licenses set forth in Schedule A hereto (the "**Collateral**").

**SECTION 2. Security for Secured Obligations.** The grant of a security interest in and lien on the Collateral by each Grantor under this IP Security Agreement secures the payment of all Secured Obligations of such Grantor now or hereafter existing, whether direct or indirect, absolute or contingent, and whether for principal, reimbursement obligations, interest, premiums, penalties, fees, indemnifications, contract causes of action, costs, expenses or otherwise. Upon the termination of the pledge and security interest granted under the Security Agreement in accordance with Section 7.4 of the Security Agreement, the Collateral Agent, at the Company's expense, shall execute, acknowledge, and deliver to each Grantor an instrument in writing releasing the security interests in Collateral acquired under this IP Security Agreement.

**SECTION 3. Recordation.** Each Grantor authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer to record this IP Security Agreement.

SECTION 4. Execution in Counterparts. This IP Security Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 4. Grants, Rights and Remedies. This IP Security Agreement has been entered into in conjunction with the provisions of the Security Agreement. Each Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Collateral Agent with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.


SECTION 6. Governing Law. This IP Security Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.

SECTION 7. Collateral Agent. In connection with its execution and acting under this IP Security Agreement, the Collateral Agent is entitled to all rights, privileges, protections, immunities, benefits and indemnities provided to it under the Indenture, all of which are incorporated by reference herein, *mutatis mutandis*.


