DISCHARGE OF RECORDED SECURITY INTEREST


WHEREAS, pursuant to that Security Agreement dated as of August 29, 2005 (the "Security Agreement") by and among the Grantors party thereto (each a "Grantor" and collectively, the "Grantors") and Bank of America, N.A., as Administrative Agent (the "Administrative Agent") for the holders of the Secured Obligations referenced therein, the respective Grantors granted a continuing security interest in and continuing lien upon the trademarks and trademark applications (the "Trademarks") set forth on Schedule 1 attached hereto to the Administrative Agent for the ratable benefit of the holders of the Secured Obligations.
