**TERMINATION AND RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Termination and Release”) dated as of December 23, 2009, from Silver Point Finance, LLC in its capacity as collateral agent (together with its successors and permitted assigns, the “Agent”) for itself and the Secured Parties (as defined in the Pledge and Security Agreement, dated as of December 19, 2007 (the “Pledge and Security Agreement”)), to PODS HOLDING, INC., PODS, INC., PODS ENTERPRISES, INC. and the other subsidiaries of PODS Holding, Inc. (collectively the “Grantors”).

WITNESSETH:

WHEREAS, pursuant to the Pledge and Security Agreement in favor of Agent and the Trademark Security Agreement dated as of December 19, 2007, in favor of Agent (the “Trademark Security Agreement”), a security interest (the “Security Interest”) was granted by Grantors to Agent in the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office, at Reel 3683, Frame 0162 on December 20, 2007; in the Canadian Intellectual Property Office on May 16, 2008; with the World Intellectual Property Organization on September 18, 2008; and in the Mexican Industrial Property Institute on January 8, 2009; and

WHEREAS, Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral listed in the Trademark Security Agreement;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Agent hereby states as follows:


1. Definitions. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Pledge and Security Agreement and the Trademark Security Agreement.

2. Release of Security Interest. Agent hereby terminates, releases, and discharges its Security Interest in the Trademark Collateral including, but not limited to, the Trademark Collateral listed in Exhibit I attached hereto. Any and all right, title, or interest of Agent in such Trademark Collateral and all proceeds thereof, including without limitation, the goodwill of the business connected with the use of, and symbolized by, the Trademark Collateral and any and all causes of action which may exist by reason of infringement of the Trademark Collateral, shall hereby cease and become void.

3. Further Assurances. Agent hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest in the Trademark Collateral contemplated hereby.


