**TERMINATION AND RELEASE OF
SECURITY INTEREST IN
TRADEMARKS**

WHEREAS Arclin Surfaces Inc. (formerly known as Dynea Overlays, Inc.) ("Grantor"), entered into a Second Lien Trademark Security Agreement recorded July 17, 2007 at the United States Patent and Trademark Office at Reel 3582, Frame 0183 (the "Security Agreement") with UBS AG, Stamford Branch ("UBS"), as collateral agent for the secured parties.

WHEREAS, Grantor granted UBS, as collateral agent for the secured parties, under the terms of the Security Agreement, a continuing security interest (the "Security Interest") in favor of UBS, as collateral agent for the secured parties, in and to the Trademark Collateral described in the Security Agreement, including without limitation the trademarks listed in Schedule A.

WHEREAS UBS entered an agreement with The Bank of New York Mellon ("BNYM"), as successor collateral agent for the secured parties, recorded April 1, 2009 at the United States Patent and Trademark Office at Reel 3963, Frame 0275 under which UBS assigned the Security Interest to BNYM, as successor collateral agent for the secured parties.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, BNYM, as successor collateral agent for the secured parties, without representation, warranty or recourse express or implied, hereby releases the Security Interest, and waives and relinquishes all of its right, title and interest in or to the Trademark Collateral.
