RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "Release") is made as of December 23, 2009 by Wells Fargo Business Credit, Inc., a Minnesota corporation (the "Secured Party") in favor of The Fanning Corporation, an Illinois corporation (the "Debtor").

WHEREAS, the Debtor and the Secured Party have executed that certain Patent and Trademark Security Agreement dated as of January 27, 2004 (the "Security Agreement") pursuant to which the Debtor has granted to the Secured Party a security interest in the Patents (as defined below) and the Trademarks (as defined below) (the "Security Interest"), and such recorded with the United States Patent and Trademark Office on July 1, 2004 at Reel/Frame 015521/0338 and at Reel/Frame 3002/0367;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party agrees as follows:

1. Release. The Secured Party hereby acknowledges and agrees that the Security Interest is hereby satisfied, released and terminated in all respects and the Security Agreement is hereby terminated. All right, title and interest, if any, held by the Secured Party in the Patents and/or Trademarks is hereby reconveyed and transferred by Secured Party to the Debtor.

2. Definitions. The following terms shall have the meanings set forth below:

"Patents" means all right, title and interest in and to patents or applications for patents, together with fees or royalties with respect thereto, and including without limitation the right to sue for past infringement and damages therefor, and licenses thereunder; in each case to the extent that the Debtor has any rights with respect thereto, including, without limitation, the patents listed on Exhibit A to this Release.

"Trademarks" means all right, title and interest in and to (i) trademarks, service marks, collective membership marks, registrations and applications for registration for each, and the respective goodwill associated with each, (ii) licenses, fees or royalties with respect thereto, (iii) the right to sue for past, present and future infringement and/or dilution and damages therefor, and (iv) all licenses thereunder; in each case to the extent that the Debtor has any rights with respect thereto, including, without limitation, the marks listed on Exhibit B to this Release.

3. The Secured Party shall execute and deliver such releases, termination statements or directions as Debtor may reasonably request. Debtor is authorized by the Secured Party to file any termination statements required to terminate any security interest in the patents and/or trademarks of Debtor.

4. Miscellaneous. A carbon, photographic or other reproduction of this Release shall have the same force and effect as the original for all purposes. This Release shall be governed by the internal law of Wisconsin without regard to conflicts of law provisions.
