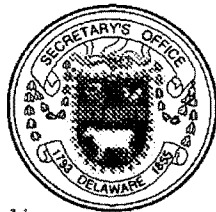

2. The Corporation was originally incorporated on the 4th day of February, 1926 under the laws of the State of Delaware.

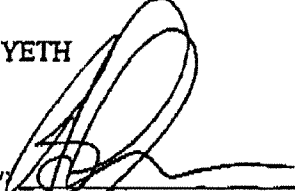
3. The name of the limited liability company into which the Corporation shall be converted, as set forth in its Certificate of Formation, is Wyeth LLC.
