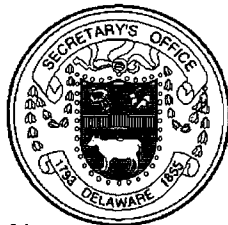

2. The Corporation was originally incorporated on the 4th day of February, 1926 under the laws of the State of Delaware.


