## **RELEASE OF ASSIGNMENT FOR SECURITY OF TRADEMARKS**

THIS RELEASE is made as of this 8th day of February, 2010, by The Bank of New York Mellon Trust Company, N.A., as Collateral Agent (“Bank of New York”) in favor of Libbey Glass Inc. This release is made and accepted without covenant or warranty, express or implied, at law or in equity, and without recourse to or warranty of the Trustee or Collateral Agent in any event or in any contingency.

Bank of New York consents and agrees to execute and deliver, at the request and cost of Company, such further instruments, documents and release forms as Company

may reasonably request to more effectively, release, terminate and extinguish any such liens and security interests upon such trademarks.

This Release shall be binding upon Bank of New York's legal representatives, assigns and successors.
