**TERMINATION OF SECURITY INTEREST  
(Intellectual Property)**

This **TERMINATION OF SECURITY INTEREST**, dated as of January 29, 2010, is made by Bank of America, N.A., as agent for certain lenders (the "Agent").

WHEREAS, pursuant to the terms of that certain Patent and Trademark Security Agreement dated March 13, 2007 (the "Security Agreement"), Kehe Food Distributors, Inc., ("Kehe"), Kehe Enterprises, Inc., ("Enterprises"), Kehe/Eye Level, Inc., ("Eye Level"), J & J Romeoville Property, L.P., ("J & J L.P."), J&J Romeoville Property, L.L.C., ("J&J L.L.C."), Kehe Foods Texas, L.P. ("Kehe Foods Texas") and Kehe TX Limited Partners LLC ("Kehe TX", and together with Kehe, Enterprises, Eye Level, J & J L.P., J&J L.L.C. and Kehe Foods Texas, each a "Grantor" and collectively, the "Grantors"), have granted to the Agent a security interest in and lien on all of Grantors' right, title, and interest in, to and under the Trademark Collateral and Patent Collateral (each as defined in the Security Agreement), including without limitation a security interest in certain trademarks described on Schedule A hereto (collectively, the "Intellectual Property Collateral");

WHEREAS, the security interest granted to the Agent was recorded at the United States Patent and Trademark Office on March 15, 2007 at Reel 3501 and Frame 0512 and 0528; and

WHEREAS, the Agent has agreed to terminate and release its security interest in the Intellectual Property Collateral, as herein provided;

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby terminates the Security Agreement and terminates, cancels and releases all liens and security interests it has against the Intellectual Property Collateral.

The Agent shall take all further actions, and provide to Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Termination of Security Interest.



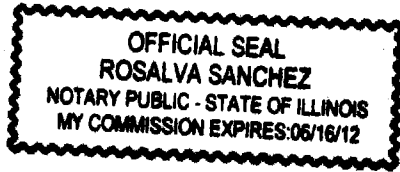
