**RELEASE OF SECURITY INTEREST IN  
SELECTED INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of February 4, 2010, is made by UBS AG, STAMFORD BRANCH, in its capacity as collateral agent pursuant to the Security Agreement (the "Collateral Agent").

**WITNESSETH**

WHEREAS, the Pledgor is party to a Security Agreement dated March 1, 2006 (the "Security Agreement"), and pledged and granted to the Collateral Agent a security interest in and continuing lien on all of its right, title and interest in, to and under certain property and other assets of the Borrower, including Trademark Collateral (defined below);

WHEREAS, pursuant to the Security Agreement, the Pledgor executed (i) the Trademark Security Agreement by and among the Pledgor and the Collateral Agent for the Secured Parties dated March 28, 2008 and recorded with the U.S. Patent and Trademark Office on April 1, 2008 at Reel/Frame No. 3750/0508, and (ii) the Trademark Security Agreement by and among the Pledgor and the Collateral Agent for the Secured Parties dated May 7, 2008 and recorded with the U.S. Patent and Trademark Office on May 13, 2008 at Reel/Frame No. 3776/0619, pursuant to which the Pledgor pledged and granted to the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under its Trademarks, all Goodwill associated with its Trademarks, and all proceeds of any and all of the foregoing (the "Trademark Collateral");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:

The Collateral Agent, on its own behalf and on behalf of the Secured Parties, hereby relinquishes, terminates, cancels and releases any and all right, title and interest it may have or have acquired through the Security Agreement, Trademark Security Agreement or otherwise, in and to the intent-to-use trademark applications listed on Schedule I attached hereto and incorporated herein by reference (collectively, the "Released Collateral").

The parties hereto shall cause this Release to be filed with the United States Patent and Trademark Office for the purpose of recording the release of the Secured Parties' security interest in the Released Collateral.
