RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Dura Global Technologies, Inc., a Michigan corporation ("Dura Global"), Atwood Mobile Products, Inc., an Illinois corporation ("Atwood Mobile") and Dura Operating Corp., a Delaware corporation ("Dura Operating", and together with Dura Global and Atwood Mobile, "Grantors") each granted a security interest in and lien upon certain trademarks, trademark applications and related rights to General Electric Capital Corporation, as Collateral Agent ("Secured Party") as set forth in the Trademark Security Agreement, dated as of June 27, 2008, by Grantors in favor of Secured Party (the "Trademark Security Agreement");

1. releases and conveys to each Grantor any and all liens, security interests, right, title and interest of Secured Party granted pursuant to the Trademark Security Agreement in the Trademarks, without recourse or representation or warranty, express or implied, of any kind or nature whatsoever;
2. agrees that any power of attorney or similar rights granted by any Grantor to Secured Party pursuant to the Trademark Security Agreement is terminated; and
3. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.


