## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into as of the 2<sup>nd</sup> day of March, 2010 ("Effective Date") by and between Halmode Apparel, Inc., a Delaware corporation, with an office at 600 Kellwood Parkway, Saint Louis, Missouri 63017 ("Assignor"), and Kellwood Company, a Delaware corporation, with an office at 600 Kellwood Parkway, Saint Louis, Missouri 63017 ("Assignee").

WHEREAS, Assignor is the owner of United States trademark registration set forth on Schedule A attached hereto (collectively, the "Mark");

WHEREAS, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, the Mark together with the goodwill of the business associated therewith;

NOW, THEREFORE, in view of the foregoing premises, and the mutual undertakings contained herein, Assignor hereby assigns, transfers, and sets over to Assignee the entire right, title and interest in and to the Mark for the United States, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States, now and hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties, or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Mark, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor hereby requests the U.S. Commissioner of Patents and Trademarks to record Assignee as assignee and owner of the Mark.

Assignor represents and warrants, and Assignee acknowledges that, subject to the security interests in the Mark held by Bank of America, N.A., One South Wacker, Suite 3400, Chicago, Illinois 60606 and Wells Fargo Bank, N.A., 230 West Monroe Street, Suite 2900, Chicago, Illinois 60606: (i) it is the sole and exclusive owner of the entire right, title and interest in and to the Mark (including the corresponding rights set forth in the above), free and clear of any other liens, security interests or encumbrances; (ii) it has the full right and authority to execute this Assignment and to assign to Assignee the rights assigned herein; and (iii) it has not executed, and will not execute, any agreement or other instrument in conflict herewith.

Assignor shall take all further actions, and provide to Assignee, Assignee's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation), requested by Assignee to more fully and effectively effectuate the purposes of this Assignment, including, without limitation, with respect to the following: (1) the preparation and prosecution of any application for registration, or any application for renewal of a registration, relating to any of the rights assigned herein; and (2) the prosecution or defense of any interference, opposition, infringement or other proceedings that may arise in connection with any of the rights assigned herein, including, without limitation, testifying as to any facts relating to the Mark and this Assignment.


Assignor and Assignee agree that nothing set forth herein shall be deemed to amend, modify, supplement, reduce or expand the warranties and representations of Assignor, or the liability of and indemnification by Assignor with respect thereto, set forth in the Agreement.


