TERMINATION OF SECURITY INTEREST FOR TRADEMARKS

This is a Termination of Security Interest, dated as of February 23, 2010, executed by PNC Bank, National Association, as Agent, as secured party, 249 Fifth Avenue, 6th Floor, One PNC Plaza, Pittsburgh, PA 15222 (the "Secured Party"), releasing all security interests of the Secured Party in the Trademark Collateral (defined below) owned by Crucible Materials Corporation ("Crucible").

Recitals

WHEREAS, the Secured Party was assigned by Crucible, a security interest in certain trademarks of Crucible, listed on **Schedule A** hereto (the "Trademark Collateral"), as evidenced by the Notice of Security Interest in Trademarks dated as of August 16, 2002 and recorded in the United States Patent and Trademark Office on October 15, 2002 at Reel 2561, Frame 0478;

WHEREAS, Crucible has satisfied its obligations to the Secured Party and desires the termination of the Secured Party's security interest in the Trademark Collateral;

WHEREAS, the Termination of Security Interest which was previously recorded on August 30, 2004 at Reel 2931, Frame 0288 contained certain inadvertent typographical errors and omissions; and

WHEREAS, certain trademarks of Crucible which were previously listed on the Termination of Security Interest for Trademarks recorded on August 30, 2004, are included on **Schedule A** hereto to correct the inadvertent omissions.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby terminates all of the Secured Party's security interests in the Trademark Collateral, including, without limitation, that set forth at Reel 2561, Frame 0478.
