**RELEASE OF SECURITY INTEREST  
(TRADEMARKS)**

1. The parties to this agreement are North Pacific Group, Inc., an Oregon corporation with offices at 10200 SW Greenburg Rd., Portland, OR 97223 (hereinafter referred to as "North Pacific Group") and Wells Fargo Capital Finance, Inc., a California corporation formerly known as Wells Fargo Foothill, Inc., with offices at 2450 Colorado Avenue, Suite 3000 West, Santa Monica, CA 90404 (hereinafter referred to as "Wells Fargo").

2. Pursuant to a Trademark Security Agreement executed on December 22, 2006 by North Pacific Group and recorded in the U.S. Patent and Trademark Office under reel/frame 003452/0391, Wells Fargo has been granted for the benefit of the Lenders and the Bank Product Provider (as such terms are defined therein) a security interest in the Trademark Collateral (as such term defined therein), which includes but is not limited to the trademarks identified on the attached Exhibit A (the "Released Trademarks").

4. Wells Fargo shall retain its interest in all Trademark Collateral other than the Released Trademarks, and all rights of Wells Fargo in connection with such Trademark Collateral and the security interest of Wells Fargo in such Trademark Collateral are expressly reserved.
