**RELEASE AND TERMINATION OF SECURITY INTEREST  
IN PATENTS, TRADEMARKS AND COPYRIGHTS**

This RELEASE and TERMINATION is made by CITIZENS BANK OF PENNSYLVANIA, a Pennsylvania state chartered bank, 525 William Penn Place, Pittsburgh, Pennsylvania 15219 (hereinafter "CBP").

WHEREAS, Commercial and Architectural Products, Inc. ("CAP"), formerly a corporation of the State of Illinois, and CBP entered an Intellectual Property Security Agreement (the "Security Agreement") on March 4, 2004 and recorded in the U.S. Patent and Trademark Office on March 15, 2004, at Reel 015074 Frame 0412 and Reel 002928 and Frame 0378 in which Security Agreement CAP granted a security interest to CBP in certain Patents and Trademarks and Copyrights that CAP then owned. These Patents, Trademarks and Copyrights are identified respectively in Exhibits A, B and C attached hereto.

For good and valuable consideration, the receipt and sufficiency of which is acknowledged, CBP hereby releases and terminates all rights that it was granted in said Security Agreement including the security interest granted in those Patents, Trademarks and Copyrights identified in Exhibits A, B and C attached hereto, and further requests that the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments, to note in the record, the termination and release of said Security Agreement and the security interest in and to the Patents, Trademarks, and Copyrights.
