**FIRST AMENDMENT TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This First Amendment to Intellectual Property Security Agreement (this "First Amendment") is made as of the 23rd day of February, 2010 by and among (a) each of the Persons listed on Schedule I hereto (each such Person, individually, a "Borrower" and, collectively, the "Borrowers"), (b) each of the Persons listed on Schedule II hereto (each such Person, individually, a "Guarantor" and, collectively, the "Guarantors") (the Borrowers and the Guarantors are hereinafter referred to, individually, as a "Grantor" and, collectively, as the "Grantors"), and (c) BANK OF AMERICA, N.A., a national banking association, as collateral agent (in such capacity, the "Collateral Agent") for its own benefit and the benefit of the other Credit Parties (as defined in the Credit Agreement referred to below), in consideration of the mutual covenants contained herein and benefits to be derived herefrom.

WITNESSETH:

WHEREAS, reference is made to that certain Credit Agreement, dated as of May 3, 2006 (as amended, modified, supplemented or restated and in effect from time to time, the "Credit Agreement"), by and between, among others, (i) the Grantors, (ii) Bank of America, N.A., as administrative agent (in such capacity, the "Administrative Agent") for its own benefit and the benefit of the other Credit Parties, (iii) the Collateral Agent, and (iv) the lenders from time to time party thereto (individually, a "Lender" and, collectively, the "Lenders"), pursuant to which the Lenders have agreed to make Loans to the Borrowers, and the L/C Issuer has agreed to issue Letters of Credit for the account of the Borrowers, upon the terms and subject to the conditions specified in the Credit Agreement;

WHEREAS, as a condition to the Lenders agreeing to make Loans and to the L/C Issuer agreeing to issue Letters of Credit, the Lenders required, among other things, that the Grantors execute and deliver that certain Intellectual Property Security Agreement, dated as of May 3, 2006 (as amended, modified, supplemented or restated and in effect from time to time, the "IP Security Agreement"), by and among the Grantors and the Collateral Agent, pursuant to which each Grantor granted to the Collateral Agent (for its own benefit and the benefit of the other Credit Parties) a security interest in and to the IP Collateral (as defined therein), in order to secure the Secured Obligations (as defined therein);

WHEREAS, the Grantors have advised the Collateral Agent that The Sports Authority Michigan, Inc., a Michigan corporation ("TSA Michigan"), and TSA Corporate Services, Inc., a Colorado corporation ("TSA Services"), have each been merged with and into TSA Stores, Inc., a Delaware corporation ("TSA"), in each case, with TSA being the surviving entity. Therefore, TSA Michigan and TSA Services are no longer Borrowers and Grantors party to the IP Security Agreement;

WHEREAS, pursuant to a certain Intellectual Property Purchase Agreement, dated as of February 12, 2010 (the "Hilco Purchase Agreement"), by and between TSA, as Purchaser, and Hilco TAG, LLC, a Delaware limited liability company ("Hilco"), as Seller, TSA has purchased the Hilco IP Assets (as defined herein); and

WHEREAS, the Grantors and the Collateral Agent now wish to amend, modify and supplement the IP Security Agreement to include the newly acquired Hilco IP Assets, as more particularly set forth in this First Amendment.

NOW, THEREFORE, in consideration of the premises contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Definitions. All capitalized terms used herein and not otherwise defined shall have the same meaning herein as in the IP Security Agreement or the Credit Agreement (as applicable).
2. Amendment to Exhibit B. **EXHIBIT B** to the IP Security Agreement is hereby supplemented to include the Patents acquired by TSA pursuant to the Hilco Purchase Agreement (the "Hilco Patents") more particularly described on **EXHIBIT B** attached hereto.
3. Amendment to Exhibit C. **EXHIBIT C** to the IP Security Agreement is hereby supplemented to include the Trademarks acquired by TSA pursuant to the Hilco Purchase Agreement (the "Hilco Trademarks" and, collectively with the Hilco Patents, the "Hilco IP Assets") more particularly described on **EXHIBIT C** attached hereto.
4. Effect on IP Security Agreement. Except as otherwise expressly provided herein, all of the terms and conditions of the IP Security Agreement remain in full force and effect. Each of the Grantors hereby ratifies, confirms, and reaffirms that all of the representations and warranties of the Grantors contained in the IP Security Agreement are true and correct in all material respects on and as of the date hereof, except to the extent that such representations and warranties specifically refer to an earlier date, in which case they are true and correct in all material respects as of such earlier date.
5. Counterparts. This First Amendment may be executed in several counterparts and by each party on a separate counterpart, each of which when so executed and delivered shall be an original, and all of which together shall constitute one instrument. Delivery of an executed counterpart of a signature page to this First Amendment by telecopy or other electronic transmission shall be effective as delivery of a manually executed counterpart of this First Amendment.
6. Entire Agreement. This First Amendment expresses the entire understanding of the parties with respect to the transactions contemplated hereby. No prior negotiations or discussions shall limit, modify, or otherwise affect the provisions hereof.
7. Severability. Any determination that any provision of this First Amendment or any application hereof is invalid, illegal or unenforceable in any respect and in any instance shall not effect the validity, legality, or enforceability of such provision in any other instance, or the validity, legality or enforceability of any other provisions of this First Amendment.

8. Consultation with Counsel. Each of the Grantors represents and warrants that it has consulted with independent legal counsel of its selection in connection with this First Amendment and is not relying on any representations or warranties of the Collateral Agent or the Lenders or their counsel in entering into this First Amendment.
9. Governing Law. This First Amendment shall be governed by, and construed in accordance with, the laws of the State of New York.
10. Further Assurances. Each Grantor agrees, at its own expense, to execute, acknowledge, deliver and cause to be duly filed all such further documents, financing statements, agreements and instruments and take all such further actions as the Collateral Agent may from time to time reasonably request to better assure, preserve, protect and perfect the security interest in the Hilco IP Assets granted pursuant to the IP Security Agreement, as amended, modified and supplemented pursuant to this First Amendment, and the rights and remedies created hereby or the validity or priority of such security interest, including the payment of any fees and taxes required in connection with the execution and delivery of this First Amendment, the granting of the security interest and the filing of any financing statements or other documents in connection herewith or therewith.


