NOTICE OF FULL RELEASE OF SECURITY INTEREST

This Release of a Security Interest is made this 26<sup>th</sup> day of March 2010, by SunTrust Bank, a Georgia banking corporation, (the "Bank").

WHEREAS, reference is made to a certain Loan Agreement dated September 29, 2006, ("Agreement") by and between the Bank and Marble's Cutlery, L.L.C., a Tennessee limited liability company, (the "Borrower")

WHEREAS, in connection with the Agreement, the Borrower granted to the Bank a Security Interest in certain of the Borrower's assets, including, to its Intellectual Property ("Collateral") (as defined in the Security Agreement), including without limitation to the Patents, Trademarks and Copyrights set forth in Exhibits A and B attached hereto; and

WHEREAS, Borrower commenced a case under Chapter 7, title 11, U.S.C. on September 12, 2009, before the United States Bankruptcy Court, Eastern District of Tennessee (the "Court"), Case No. 1:09-bk-15834;

WHEREAS, pursuant to certain Orders of the Court the trustee in bankruptcy for the Borrower, Jerrold D. Farinash (the "Trustee"), is authorized to sell, transfer and assign the Collateral to Smoky Mountain Knife Works, a Tennessee corporation (the "Buyer") for good and valuable consideration, free and clear of any liens, claims or encumbrances;

WHEREAS, the Trustee and the Bank have agreed by separate agreement that the estate of the Borrower shall pay over to the Bank said consideration paid by the Buyer in full satisfaction of Borrower's debt to the Bank, and the Bank desires to release and discharge its security interest in the Collateral, including without limitation the Patents, Trademarks and Copyrights identified in Exhibits A and B;

NOW, THEREFORE, in consideration of the premises, the mutual obligations set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Bank hereby releases and remits any and all right, title and interest in and to the Collateral, including without limitation to the Patents, Trademarks and Copyrights identified in Exhibits A and B, and hereby authorizes the Borrower or the Trustee or the authorized representative of either to record this Release with the United States Patent and Trademark Office and the United States Copyright Office.



