
WHEREAS, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office;

The Agent agrees, at the Grantor's expense, to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the released collateral described herein.
