**RELEASE AND DISCHARGE OF SECURITY INTERESTS
IN UNITED STATES TRADEMARKS**

WHEREAS pursuant to a *First Lien Intellectual Property Security Agreement* dated as of June 14, 2007 (as having been amended, restated or otherwise modified from time to time (as the case may be), the "First IP Security Agreement"), by and among Edgestone CD Acquisition Corp. ("Edgestone"), Custom Direct, Inc. ("CDI"), Custom Direct LLC ("CDLLC"), Unique Checks, Inc. ("Unique"), EZShield LLC ("EZShield") and BNP Paribas as *First Lien Administrative Agent* for a group of third parties lenders ("BNP"), security interests were granted in favour of BNP in and to the trademarks, trademark registrations and applications for trademark registrations set out in Schedule "A" attached hereto (the "Trademarks");

WHEREAS pursuant to a *Second Lien Intellectual Property Security Agreement* dated as of June 14, 2007 (as having been amended, restated or otherwise modified from time to time (as the case may be), by and among Edgestone, CDI, CDLLC, Unique, EZShield and BNP as *Second Lien Administrative Agent* for a group of third parties lenders, security interests were granted in favour of BNP in and to the Trademarks;

WHEREAS the First IP Security Agreement and the Second IP Security Agreement were recorded in the United States Patent and Trademark Office (the "USPTO") at Reel/Frame Numbers 3576/0637 and 3576/0680 respectively;

WHEREAS since the recordation of the First IP Security Agreement and the Second IP Security Agreement some of the Trademarks were ultimately transferred to EZShield, Inc.;

WHEREAS pursuant to a Notice of Continuation of Security Interest dated as of May 18, 2009 (the "Notice of Continuation") by and among CDLLC, CDI, EZShield Holdings LLC, EZShield, Inc. and recorded in the USPTO at Reel/Frame Numbers 3988/0935, CDLLC, CDI, EZShield Holdings LLC and EZShield, Inc. agreed and provided notice, *inter alia*, that the transferred Trademarks remained subject to the liens and security interests granted to BNP as *First Lien Administrative Agent* under the First IP Security Agreement and as *Second Lien Administrative Agent* under the Second IP Security Agreement that were in effect immediately prior to the transfer;

AND WHEREAS BNP both as *First Lien Administrative Agent* under the First IP Security Agreement and as *Second Lien Administrative Agent* under the Second IP Security Agreement wishes to release all of its interest in and to the Trademarks under those agreements, included those recorded in the USPTO.

NOW THEREFORE, in consideration of One United States Dollar (US \$1), and other good and valuable consideration, the receipt and adequacy of which are acknowledged, BNP both as *First Lien Administrative Agent* and as *Second Lien Administrative Agent*:

1. confirms that it has not assigned or otherwise disposed of its interest in and to the Trademarks; and
2. hereby releases and discharges the full interest granted to BNP both as *First Lien Administrative Agent* and as *Second Lien Administrative Agent* in and to the Trademarks.


