

IN UNITED STATES TRADEMARKS**


FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Tenneco Inc., Tenneco Automotive Operating Company Inc., Tenneco International Holding Corp., Tenneco Global Holdings Inc., The Pullman Company, TMC Texas Inc. and Clevite Industries Inc., each a Delaware corporation (each, a "Grantor" and collectively, the "Grantors") with principal offices at 500 North Field Drive, Lake Forest, Illinois 60045 and U.S. Bank National Association (as successor to Wachovia Bank, National Association), as Collateral Agent, with principal offices at 5555 San Felipe Street, Suite 1150, Houston, Texas 77056 (the "Collateral Agent"), hereby agree to amend Schedule A to the Security Interest in United States Trademarks executed by Grantors and Collateral Agent on June 19, 2003 and recorded at the U.S. Patent and Trademark Office ("Security Interest"). Schedule A was previously amended and restated in its entirety pursuant to the Amendment to Security Interest in United States Trademarks executed by Grantors and Collateral Agent in April 2005 and recorded at the U.S. Patent and Trademark Office and further amended by the Amendment to Security Interest in United States Trademarks executed by Grantors and Collateral Agent in April of 2006, 2007, 2008 and 2009 and recorded at the U.S. Patent and Trademark Office. Schedule A to the Security Interest, as supplemented by Schedules B through E to the Security Interest, shall be further amended to include Schedule F attached hereto.






