ASSIGNMENT AND RELEASE OF SECURITY INTEREST


This Assignment and Release of Security Interest (this "Release") is dated as of April 30, 2010. Reference is hereby made to (a) that certain Trademark Security Agreement (the "Canadian Grantor Agreement") dated as of June 29, 2007, by and between Syscon Holdings Ltd., a British Columbia company ("Syscon Holdings"), Syscon Justice Systems Canada Ltd., a British Columbia company ("Syscon Canada"), and Appaloosa Acquisition Company Ltd., a British Columbia company ("Appaloosa"), and The Bank of New York Mellon Trust Company, N.A., as trustee ("Trustee"), and (b) that certain Amended and Restated Trademark Security Agreement (the "US Grantor Agreement"; the Canadian Grantor Agreement and the US Grantor Agreement shall be referred to collectively, as the "Agreements" and each individually, as an "Agreement") dated as of June 29, 2007, by and among T-Netix, Inc., a Delaware corporation ("T-Netix"), Securus Technologies, Inc., a Delaware corporation ("Securus"), Telequip Labs, Inc., a Nevada corporation ("Telequip"), T-Netix Telecommunications Services, Inc., a Texas corporation ("Telecommunications"; Syscon Holdings, Syscon Canada, Appaloosa, T-Netix, Securus, Telquip, and Telecommunications shall be referred to collectively, as "Grantors" and each individually, as a "Grantor"), and Trustee.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Trustee hereby notifies, acknowledges and agrees with each Grantor that (i) the security interest granted by such Grantor in the Trademark Collateral (as defined in each Agreement) including, without limitation, the security interest granted in the trademarks listed on the attached **Schedule A**, and the goodwill associated therewith (collectively, the "Marks"), is terminated, released and discharged, (ii) Trustee hereby releases and forever discharges all of its right, title and interest of any kind or nature in the Marks granted, assigned or conveyed pursuant to the Agreements, and (iii) any right, title or interest of Trustee in the Marks shall hereby cease and become void. Trustee hereby retransfers and reassigns to each appropriate Grantor, without representation or warranty, all of Trustee's right, title and interest in and to the Marks.

Trustee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the termination, release and discharge of the security interest contemplated hereby.
