INTELLECTUAL PROPERTY TERMINATION AND RELEASE

THIS INTELLECTUAL PROPERTY TERMINATION AND RELEASE (this "Agreement") dated as of May 5, 2010, is made by and between Papa Murphy's International, Inc., a Delaware corporation ("Grantor") and Wells Fargo Bank, National Association, as Administrative Agent ("Agent") pursuant to that certain Amended and Restated Credit Agreement dated as of October 30, 2009 (as amended, restated, amended and restated, supplemented or otherwise modified, the "Credit Agreement") by and among Grantor, Papa Murphy's Company Stores, Inc., a Washington corporation ("PM Company Stores"), and Papa Murphy's Canada, Inc., a Delaware corporation, the lenders from time to time party thereto, and Agent. Capitalized terms used herein, but otherwise not defined, shall have the meanings ascribed to them in the Original IP Security Agreement (as defined below).

RECITALS

- A. Grantor and PM Company Stores entered into that certain Credit Agreement, dated as of June 30, 2004 (the "Original Credit Agreement"), with Agent and the lenders party thereto; which Original Credit Agreement was amended and restated pursuant to the terms of the Credit Agreement.
- B. Grantor granted a security interest in its trademarks and trademark applications identified on <u>Schedule A</u> attached hereto (collectively, the "<u>Trademarks</u>") to Agent pursuant to that certain Intellectual Property Security Agreement dated as of June 30, 2004 (the "<u>Original IP Security Agreement</u>").
- C. In order to evidence the grant of security interests under the Original IP Security Agreement, Grantor caused the due execution and delivery of certain filings in the United States Patent and Trademark Office recorded at Reel 2883 Frame 0934 on July 1, 2004 and Reel 3414 Frame 0815 on October 24, 2006.
- D. The obligations under the Credit Agreement, the other Loan Documents and all documents and agreements delivered pursuant to the Credit Agreement or in connection therewith have been terminated.
- E. Agent has agreed to terminate and release all security interests granted to or held by Agent as security for the obligations under the Credit Agreement and the other Loan Documents.
- F. In order to evidence the release of the security interests granted pursuant to the Original IP Security Agreement, Grantor has requested, and Agent has agreed, to execute and deliver this agreement.

NOW THEREFORE, with intent to be legally bound hereby and for other good and valuable consideration, receipt of which is hereby acknowledged, Grantor and Agent hereby agree as follows:

- SECTION 1. Release and Discharge. Agent agrees to terminate and release all security interests granted to or held by it in the Trademarks pursuant to the Original IP Security Agreement as security for the obligations under the Credit Agreement and the other Loan Documents. Agent agrees that the Trademarks securing the obligations are hereby released and discharged from the security interests granted pursuant to the Original IP Security Agreement and such security interests are hereby reconveyed to Grantor automatically and without further action by Agent.
- SECTION 2. <u>Representation and Warranty</u>. Agent represents and warrants that it has the authority to execute and deliver this Agreement on its own behalf and on behalf of the Secured Parties.
- SECTION 3. <u>Effectiveness</u>. This Agreement becomes effective when all parties hereto have executed and delivered a counterpart hereof (including by way of facsimile transmission or other electronic transmission).
- SECTION 4. <u>Further Assurances</u>. Agent agrees that it shall, from time to time, at the expense of Grantor, execute, acknowledge and deliver to Grantor and its designees, successors or assigns such instruments, agreements, and other documents as Grantor or its successors or assigns shall reasonably request in order to further evidence the releases and discharges described in <u>Section 1</u> above.
- SECTION 5. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of New York without giving effect to the conflict of laws principles thereof.
- SECTION 6. <u>Counterparts</u>. This Agreement may be executed in any number of counterparts (including by facsimile transmission or other electronic transmission), each of which shall be an original, but all of which, taken together, shall constitute one and the same document.
