BIG IDEA, INC., a corporation duly organized and existing under and by virtue of the laws of the State of New York, desiring to merge itself with and into Big Idea Entertainment, LLC, a limited liability company duly organized and existing under and by virtue of the laws of the State of Delaware, pursuant to the provisions of Section 1003 of the New York Limited Liability Company Law, DOES HEREBY CERTIFY as follows:

**FIRST:** The name and state of formation of each constituent entity of the merger (the "Merger") are as follows: (i) BIG IDEA, INC., a New York corporation (the "Corporation") and (ii) Big Idea Entertainment, LLC, a Delaware limited liability company (the "Company").

**SECOND:** The date of the Certificate of Incorporation and Certificate of Formation, respectively, of each constituent entity of the Merger were filed with the New York Department of State and the Delaware Secretary of State as follows: (i) the Corporation was incorporated on December 10, 2003, and (ii) the Company was formed on December 29, 2009.

**THIRD:** The Company has not filed an application for authority in the State of New York and is not to do business in the State of New York until an application for such authority has been filed with the New York Department of State.

**FOURTH:** An agreement of merger has been approved and executed by each of the domestic limited liability companies or other business entities that are to merge or consolidate.

**FIFTH:** The name of the surviving company of the Merger is Big Idea Entertainment, LLC (the "Surviving Company").

**SIXTH:** The Surviving Company may be served with process in the State of New York in any action or special proceeding for the enforcement of any liability or obligation of any domestic limited liability company, domestic business corporation or domestic other business entity previously amenable to suit in this state that is to merge and for the enforcement that is provided in the Limited Liability Company Law of the State of New York, of the right of members of any domestic limited liability company, shareholders of any domestic business

corporation or owners of any domestic other business entity to receive payment for their interests against the Surviving Company.

**SEVENTH:** Pursuant to Section 623 of the Business Corporation Law, Section 1005 of the Limited Liability Company Law of the State of New York or any applicable statute, the surviving foreign limited liability company will promptly pay to the shareholders of each domestic business corporation, members of each domestic limited liability company or owners of any constituent other business entity the amount, if any, to which they shall be entitled under the provisions of the Business Corporation Law of the State of New York, Limited Liability Company Law of the State of New York and any applicable statute relating to the right of shareholders, members and owners to receive payment or their interest.

**EIGHTH:** The Secretary of State of New York is designated as agent of the Surviving Company upon whom process against it may be served. The post office address within the State of New York to which the Secretary of State shall mail a copy of any process against the Surviving Company served upon him or her is: c/o CT Corporation System, 111 Eighth Avenue, New York, NY 10011.

**NINTH:** The Merger of the Surviving Company, which is a foreign entity, is permitted by the laws of its jurisdiction and is in compliance herewith.

**TENTH:** The Agreement and Plan of Merger is on file at a place of business of the Surviving Company. Such address of the Surviving Company is: Big Idea Entertainment, LLC, 85 Fifth Avenue, 6th Floor, New York, NY 10003.

**ELEVENTH:** A copy of the Agreement and Plan of Merger will be furnished by the Surviving Company on request and without cost to any member of any domestic limited liability company or to any person holding an interest in any other business entity that is to merge pursuant to such agreement.

**TWELFTH:** The Merger shall be effective on December 31, 2009.
