RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT

THIS RELEASE dated as of May 14, 2010 (this "Release") is made by NexBank, SSB ("NexBank") under that certain Second Lien Trademark Security Agreement between Electrical Components International, Inc. (successor by merger to Wire Harness Contractors, Inc. ("ECI")) and UBS AG, Stamford Branch ("UBS") dated as of May 1, 2006, and recorded in the records of the United States Patent and Trademark Office ("PTO") at Reel 3310/Frame 0122, that certain Second Lien Trademark Security Agreement between Noma O.P., Inc. ("Noma") and UBS dated as of February 16, 2007, and recorded in the records of the PTO at Reel 3491/Frame 0180, that Supplemental Trademark Security Agreement to Second Lien Trademark Security Agreement between ECI and UBS dated as of September 23, 2008, and recorded in the records of the PTO at Reel 3858/Frame 0439, that certain Assignment and Assumption Agreement between NexBank and UBS dated as of April 3, 2009, and recorded in the records of the PTO at Reel 3966/Frame 0322, and that certain Supplemental Second Lien Trademark Security Agreement between Noma and NexBank dated as of April 3, 2009, and recorded in the records of the PTO at Reel 3966/Frame 0339 (collectively, the "Second Lien Trademark Security Agreement") (ECI and Noma, collectively referred to herein as "Grantors");

W I T N E S S E T H:

WHEREAS, pursuant to the Second Lien Trademark Security Agreement, the Grantors granted to NexBank a security interest in the trademark collateral set forth on Schedule A attached hereto (the "Trademark Collateral"); and

WHEREAS, NexBank wishes to: (i) terminate the Second Lien Trademark Security Agreement against the Trademark Collateral, recorded with the United States Patent and Trademark Office; (ii) release all of its security interest in the Trademark Collateral granted

pursuant to the Second Lien Trademark Security Agreement; (iii) restore to Grantors all right, title and interest in and to the Trademark Collateral that NexBank was granted pursuant to the Second Lien Trademark Security Agreement; and (iv) to dissolve any and all liens and encumbrances respecting the Trademark Collateral granted to it by Grantors pursuant to the Second Lien Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, NexBank does hereby release its security interest in the Trademark Collateral granted pursuant to the Second Lien Trademark Security Agreement, and discharges, quit claims and relinquishes unto Grantors (in each case without recourse and without any representation or warranty) any and all rights, title and interest NexBank has in and to the Trademark Collateral and the security interest granted to NexBank in the Trademark Collateral pursuant to the Second Lien Trademark Security Agreement.
