

ENVIRONMENTAL MATTERS

- 1. Remet Corporation was notified by the New York Department of Environmental Conservation (NYDEC) by a letter dated October 25, 2002 that it may be a potentially responsible party for environmental contamination at Site No. 622006 (Erie Canal district). Accordingly, current management received an indemnity in connection with this matter when it acquired Remet Corporation in December 2003. See Environmental Indemnity dated December 2003 by and between Burmah Castrol plc and Remet Corporation for additional details. By letter dated February 16, 2010, the NYDEC issued a Proposed Remedial Action Plan. Remet is pursuing the Environmental Indemnity as well as an assigned contractual indemnity from the original owner of Remet. (See Item 1(c) on Schedule 9.1.17.)
- 2. In 2000, Remet Corporation, among numerous other parties, entered into the Omega Chemical Site Under 50 Tons Cash-Out Settlement Agreement (the "Settlement Agreement") pursuant to which it paid a 300 percent premium and was indemnified against remediation costs associated with the Omega Site, as well as future regional work associated with that Site. Angeles Chemical Co., Inc. commenced an action against Remet Corporation, among the other parties associated with the Omega Site. Remet has been afforded a defense to that litigation pursuant to the Settlement Agreement, although there is no right to indemnification for the nuisance and trespass claims, which are among the allegations in the Complaint. This matter is progressing.

 - b. In June 2007, the Company was sued in a product liability action entitled Gutierrez v. Scott Sales Co., et al. in California state court in Los Angeles County. The complaint alleges negligence and strict liability against all co-defendants for failure to provide adequate safety warnings in the marketing, distribution and sale of inherently dangerous products. In 1973-2003, while a foundry worker, the plaintiff allegedly developed silicosis and other diseases—allegedly due to long-term exposure to silica contained in materials supplied by the Company and other defendants. Remet has insurance coverage for most of the years when it sold materials to the plaintiff's employers. As the case has moved into advanced stages of pre-trial discovery, Remet Corporation and the plaintiff have engaged in serious settlement efforts which are ongoing.
 - c. As a result of the environmental matter noted in Item #1 in Schedule 9.1.15, Remet Corporation filed a lawsuit entitled Remet Corporation v. The Estate of Jame R. Pyne, et al, No CA 2009-677, in the Supreme Court, County of Oneida, New York, against the estate of a prior owner of Remet Corporation, Jame R. Pyne, deceased. This lawsuit seeks to enforce an indemnity obligation of Mr. Pyne given in connection with Mr. Pyne's sale of his stock intererst in Remet to a predecessor of the current owners. A preliminary injunction has been granted which prohibits the distribution out of the Pyne estate of certain assets pending final disposition. The discovery stage of the case is progressing pursuant to a January 15, 2010 scheduling order, which also directs the parties to be ready for trial by January 15, 2011.
