## RELEASE OF TRADEMARK SECURITY AGREEMENT

**THIS RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Release") is made as of May 28, 2010 (the "Effective Date") by Bank of America, N.A., as agent, administrative agent and collateral agent (in such capacity, the "Agent"), for the benefit of Dave & Buster's I, L.P., a Texas limited partnership (the "Parent"), Dave & Buster's Inc., Dave & Buster's of Illinois, Dave & Buster's of Georgia, Inc., Dave & Buster's of Pennsylvania, DANB Texas, Inc., Dave & Buster's of Maryland, Dave & Buster's of California, Dave & Buster's of Colorado, Inc., Dave & Buster's of New York, Inc., Dave & Buster's of Florida, Dave & Buster's of Pittsburgh, Inc., D&B Realty Holding, Inc., Dave & Buster's of Hawaii, Inc., D&B Leasing, Inc., Dave & Buster's Management Corporation, Inc., Tango Acquisition, Inc., Tango Entertainment Management Corporation, Tango License Corporation, Tango of Arizona, Inc., Tango of Arundel, Inc., Tango of Farmingdale, Inc., Tango of Franklin, Inc., Tango of Houston, Inc., Tango of Minnesota, Inc., Tango of North Carolina, Inc., Tango of Sugarloaf, Inc., Tango of Tennessee, Inc., Tango of Westbury, Inc. (collectively, the "Grantors").

**WHEREAS**, pursuant to the terms and conditions of that certain Second Amended and Restated Trademark Collateral Security and Pledge Agreement, dated as of November 1, 2004, between the Grantors and the Agent (the "Collateral Agreement"), the Grantors pledged, assigned and granted to the Agent a continuing security interest in all of their right, title and interest in and to certain collateral including, without limitation, the trademark registrations and applications set forth on Schedule 1 hereto, along with the goodwill associated therewith (collectively, the "Trademarks");

**WHEREAS**, the Agent has agreed to release its interest in and to the Trademarks and discharge the Collateral Agreement and the following:

(i) The Grant of Security Interest that was recorded with the Trademark Division of the U.S. Patent & Trademark Office on November 3, 2004 at Reel 2970 and Frame 0173;

(ii) The Grant of Security Interest that was recorded with the Trademark Division of the U.S. Patent & Trademark Office on March 16, 2005 at Reel 3067 and Frame 0914;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates the Collateral Agreement, and hereby terminates, releases, relinquishes, discharges, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks.

If and to the extent the Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the Parent.


This Release shall be governed by and construed and enforced in accordance with the laws of the State of New York without giving effect to New York choice of law doctrine.
