**ASSIGNMENT OF COLLATERAL RIGHTS UNDER
INTELLECTUAL PROPERTY
SECURITY AGREEMENT**

This ASSIGNMENT OF COLLATERAL RIGHTS UNDER INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Assignment") dated the 7th day of April, 2010, is entered into by and between Bank of America, N.A., a national banking association, as assignor (in such capacity, "Assignor"), and Woodside Capital Partners V, LLC, a Delaware limited liability company, as assignee (in such capacity, "Assignee").

WHEREAS, pursuant to the Intellectual Property Security Agreement dated as of December 17, 2007 (the "Assigned Agreement"), between Adteractive, Inc., as grantor thereunder ("Grantor"), and Assignor, as secured party thereunder, Grantor granted to Assignor a security interest in and to all of all of its Specified IP Collateral (as defined below);

WHEREAS, the Assigned Agreement was recorded: (i) with the United States Patent and Trademark Office ("USPTO") Assignment Division (Trademarks) on January 6, 2008, at Reel: 003690 Frame: 0439; (ii) with the USPTO Assignment Division (Patents) on January 6, 2008 at Reel: 020322 Frame: 0170; and (iii) Library of Congress, United States Copyright Office on January. 2, 2008 at V3560 D649; said recording filed against those trademarks, patents and copyrights as listed on Schedules A, B and C attached hereto; and

WHEREAS, Assignee desires to accept the assignment of all of Assignor's rights and interests in, to and under the Assigned Agreement with respect to the Intellectual Property Collateral to the same extent as if Assignee had executed the Assigned Agreement.

NOW, THEREFORE, in consideration of the foregoing and of other good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agrees as follows:

1. Definition of Specified IP Collateral. "Specified IP Collateral" shall have the same definition as provided in the Assigned Agreement.
2. Assignment of Assigned Agreement. Assignor hereby assigns, transfers and conveys to Assignee all of its right, title and interest in, to and under the Assigned Agreement and the collateral granted by Grantor pursuant to the Assigned Agreement.
3. Assumption of Assigned Agreement. Assignee hereby accepts the assignment contained in Section 2 and assumes all of the duties, obligation and liabilities of Assignor in, to and under the Assigned Agreement with respect to the same extent as if Assignee had executed the Assigned Agreement. Assignee hereby agrees to be bound by

the terms and provisions of the Assigned Agreement and accepts all of Assignor's rights, interests, duties, obligations and liabilities thereunder.

4. Counterparts. This Assignment may be executed in several counterparts, each of which shall be deemed an original, and all such counterparts shall constitute one and the same instrument.

5. Binding Nature. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their successors and assigns.


