**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of March 30, 2010, is made by Bank of America, N.A., as agent ("Bank of America"), in favor of Impact Forge Group, LLC ("Company") as follows:
