CONFIRMATORY TRADEMARK ASSIGNMENT

IN THE UNITED STATES PATENT AND TRADEMARK OFFICE

ASSIGNMENT

WHEREAS, API Nanofabrication and Research Corporation, a Delaware corporation, with offices at 1600 Cottontail Lane, Somerset, New Jersey 08873 ("ASSIGNOR") owns certain trademarks and/or service marks, and applications and/or registrations for such marks, as listed in Schedule 1 attached hereto, all common law rights related thereto, and all benefits, privileges, causes of action and remedies relating to any of the foregoing ("MARKS"), which MARKS are incorporated herein by this reference;


WHEREAS, Abraxis Biosensors, LLC, a Delaware limited liability company, with offices at 11755 Wilshire Blvd., Suite 2000, Los Angeles, California 90025 ("ASSIGNEE"), the successor of the ongoing and existing portion of ASSIGNOR's business to which the MARKS pertain as required by 15 U.S.C. § 1060, desires to acquire all of the right, title and interest of ASSIGNOR in, to and under the MARKS, together with the goodwill of the business symbolized by the MARKS;

WHEREAS, ASSIGNOR and ASSIGNEE have entered into, along with ASSIGNOR's parent company, API Technologies, Inc., a certain Asset Purchase Agreement dated June 11, 2010 (the "PURCHASE AGREEMENT"), assigning, among other things, all right, title and interest in and to the MARKS, including all associated goodwill, and in and to the registrations and/or applications for same from ASSIGNOR to ASSIGNEE;

NOW, THEREFORE, in consideration of the good and valuable consideration received by ASSIGNOR in connection with the PURCHASE AGREEMENT, the receipt and sufficiency of which hereby is acknowledged, ASSIGNOR does hereby sell, assign, transfer and convey unto ASSIGNEE its entire right, title and interest in and to the MARKS, and to the applications and/or registrations for the MARKS, together with the accompanying goodwill and that portion of the business to which those MARKS pertain and/ or represented and symbolized by such MARKS, all related common law rights, the right to register, renew, protect and defend such MARKS and the right to sue for past infringements of such MARKS. ASSIGNOR agrees to cooperate with ASSIGNEE to record this Assignment in the United States Patent and Trademark Office and to extend such other cooperation and perform such other acts as may be necessary or appropriate, in the opinion of ASSIGNEE, to convey, establish, evidence, maintain, defend and enforce ASSIGNEE's rights in the MARKS.
