**RELEASE OF SECURITY INTEREST**

THIS RELEASE OF SECURITY INTEREST, dated as of May 28, 2010 (this "Release") is made by Canadian Imperial Bank of Commerce, as Administrative Agent, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain Supplement to Subsidiary Pledge and Security Agreement, dated as of October 31, 2007 and recorded in the records of the United States Patent and Trademark Office (the "Security Agreement"), between The E.J. McKernan Co., an Illinois corporation, (the "Debtor") and the Secured Party.

**W I T N E S S E T H:**

WHEREAS, pursuant to the Security Agreement which was recorded on November 2, 2007 in the records of the United States Patent and Trademark Office at reel/frame 003653/0912, the Debtor granted to the Secured Party a continuing security interest in certain intellectual property, including those trademarks set forth on the attached schedule (the "Intellectual Property Collateral");


WHEREAS, the Secured Party wishes to: (i) terminate the Security Agreement as to Debtor against the Intellectual Property Collateral, recorded with the United States Patent and Trademark Office; (ii) release all of its security interest covering the Intellectual Property Collateral; (iii) restore all right, title and interest in and to the Intellectual Property Collateral to Debtor; and (iv) to dissolve any and all liens and encumbrances respecting the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Intellectual Property Collateral, and discharges, quit claims and relinquishes unto The E.J. McKernan Co.,

(in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in and the security interest granted to Secured Party in the Intellectual Property Collateral.
