PATENT AND TRADEMARK SECURITY AGREEMENT dated as of June 30, 2010 (this "Agreement"), among Smurfit-Stone Container Corporation (formerly known as Smurfit-Stone Container Enterprises, Inc.), a Delaware Corporation (the "Grantor") and DEUTSCHE BANK AG NEW YORK BRANCH ("DBNY"), as Security Agent.

Reference is made to (a) the Credit Agreement dated as of April 15, 2010 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Smurfit-Stone Container Corporation, Smurfit-Stone Container Enterprises, Inc., certain Subsidiaries of Holdings from time to time party thereto, the Lenders from time to time party thereto and DBNY, as Administrative Agent, and (b) the Guarantee and Collateral Agreement dated as of June 30, 2010 (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement"), among Smurfit-Stone Container Corporation (formerly known as Smurfit-Stone Container Enterprises, Inc.), the Subsidiaries of Holdings party thereto and DBNY, as Security Agent. The Lenders have agreed to extend credit to the Borrowers on the terms and subject to the conditions set forth in the Credit Agreement. The obligations of the Lenders to extend such credit are conditioned on, among other things, the execution and delivery of this Agreement. The Grantor is willing to execute and deliver this Agreement in order to induce the Lenders to extend such credit. Accordingly, the parties hereto agree as follows:

SECTION 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Collateral Agreement or the Credit Agreement, as applicable. The rules of construction specified in Section 1.02 of the Credit Agreement also apply to this Agreement.

SECTION 2. Grant of Security Interest. As security for the payment or performance, as the case may be, in full of the U.S. Secured Obligations, the Grantor hereby grants to the Security Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest (the "Security Interest") in all of such Grantor's right, title and interest in, to and under any Patents now owned or at any time hereafter acquired by such Grantor, including those listed on Schedule I (the "Patent Collateral") and any Trademarks now owned or at any time hereafter acquired by such Grantor, including those listed on Schedule II (the "Trademark Collateral"), and together with the Patent Collateral, the "Patent and Trademark Collateral").

SECTION 3. Collateral Agreement. The security interests granted to the Security Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Security Agent pursuant to the Collateral Agreement. The Grantor hereby acknowledges and affirms that the rights and remedies of the Security Agent with respect to the Patent and Trademark Collateral are more fully set forth in the Collateral Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Collateral Agreement, the terms of the Collateral Agreement shall govern.




